**LAUREN COURT ROAD PAVING AND WATER MAIN EXTENSION
SPECIAL ASSESSMENT DISTRICT NO. 600**

TO THE OWNERS OF THE FOLLOWING LISTED PROPERTIES:

T2N, R10E, SEC 21 CRANBROOK HILLS NO. 1 LOT 32 THROUGH 41, INCLUSIVELY

All in Bloomfield Township, Oakland County, Michigan.

PLEASE TAKE NOTICE that the Township Board of the Charter Township of Bloomfield has tentatively declared its intention to make the following improvements:

The paving and water main extension (and associated construction items) for Lauren Court within Cranbrook Hills No. 1 Subdivision, which consists of a total of 1,792.34 feet of road frontage and a total of 448,455.23 square feet (10.3 acres) of land.

For the water main extension: beginning at the existing 8" diameter water main on Lane Lake Road, an 8" diameter class 54 ductile iron water main will be extended across Lauren Court, to the east side and extend northerly along Lauren Court via open cut installation and ending at a hydrant near the property line between 5301 and 5331 Lauren Court. The water main extension includes two hydrants and the necessary water system components to complete the work.

For the road paving: a bituminous (asphalt) pavement four (4) inches thick will be placed full width over the existing gravel road. A limited amount of gravel road base repairs and drainage improvements to the ditches will be made to reasonably assure drainage of the pavement. All shoulders and disturbed areas will be covered with topsoil and sod. A maximum five (5) foot approach will be constructed to existing driveways to provide smooth transition from the newly paved roadway where necessary. Drive culverts are not included for replacement or installation unless necessary for proper drainage.

In addition, the Township Board has designated the special assessment district against which the cost of said improvements is to be assessed as consisting of all lots and parcels of land as set forth above. The to-date plans and estimates for the special assessment district are on file in the Bloomfield Township Clerk's Office, 4200 Telegraph Road, Bloomfield Hills, MI 48302.

TAKE FURTHER NOTICE that the Township Board will meet on **Monday, May 11, 2020 at 7:00 p.m.** in the Bloomfield Township Hall Auditorium, 4200 Telegraph Road, Bloomfield Hills, MI 48302 for the purpose of hearing any objections to the special assessment roll or to the special assessment district itself.

In order to appeal the amount of the special assessment to the state tax tribunal, your appearance and protest are required at the Hearing of Special Assessment. Appearance and protest may be made by a property owner or party in interest, or his or her agent, in person, or such protest is permitted by letter, without the necessity of a personal appearance.
