### To the applicant,

By filling out this application form in full, and attaching to it the materials requested, you will assist the Charter Township of Bloomfield in its effort to promptly review your application for setting a wireless communication facility within the Township. The information requested by this application is the minimum required under the Township's zoning ordinance. You should submit any additional information or materials you believe will assist the Township in its review of your proposal. This application is required for changes to antennas, ground cabinet installations or modifications, collocations, or other site work.

Under the ordinance, certain conditions allow the Township's planning official to issue a permit for an attached wireless communication facility. Other conditions require the approval of the Planning Commission or Township Board. Though you may have an idea of which process will be appropriate to your situation, you will be contacted as soon as possible when the Township staff makes this determination.

This application must be filled out in full, and must bear the signature of the property owner (or the duly authorized representative of all ownership interests) as well as the signature of the applicant, or applicant's representative. Additionally, a fee of \$1,000 must accompany this application. Incomplete applications or those submitted without the proper fee will be returned to the applicant.

Consulting Review Fees The applicant shall be responsible for any costs incurred by consultants, including but not limited to traffic and environmental, contracted by the Township to review the proposed site plan as determined by the Department pursuant to Chapter 2, Article V, Division 2, Section 2-111- 2-117.
- 3. Site plan fees submitted for Planning Commission review includes an initial review by the Design Review Board.
- 4. Other Township Department Review Fees The applicant shall be responsible for additional review fees from Township Departments/Divisions, including but not limited to Engineering and Environmental Services, Fire, Public Services, Building or Ordinance, if applicable, as adopted by the Township Board.
