The Meritorious Service Medal. Awarded for some difficult task in which crime is prevented, life and property protected, or criminals apprehended. It can also be awarded for assistance in an auxiliary capacity due to technical knowledge, expertise and / or unusual effort put forth.




Chief's Merit Award. Presented for efficient and valuable service to the department, either in carrying out a specific task, or in the performance of general duties over an extended period of time.



Lifesaving Award. Issued to a law enforcement officer who personally saves a life. Lifesaving effort normally involves, but is not limited to, any of the learned life-supporting processes: Mouth-to-mouth resuscitation, CPR, or the Heimlich maneuver for choking victims.



Officer of the Year Award. Issued to officers who have been an officer of the year at any time in their career with the Bloomfield Township Police Department.



Department Unit Commendation. This is awarded in recognition of outstanding police services performed by any departmental unit, such as the Field Training Officers unit, Traffic Investigations Unit, etc.



Oak Leaf. This is added to any of the above awards to signify a subsequent award. For example, this is what you would see on the uniform of an officer who has received two Meritorious Service Medals:





LIFE SAVING



Officer Daniel Brown, Officer Eric Pernie

On September 17, 2014 Officers Brown and Pernie responded to a residence on North Chestnut Run on a report of a possible heart attack involving a 65 year old male. After arriving on scene, it was evident to Officer Pernie the subject was having a heart attack. Officer Pernie, along with the subject's wife began CPR. Moments later, Officer Brown arrived with an AED/Lifepack system. Officers Brown and Pernie were able to deploy the AED which eventually shocked the patient out of cardiac arrest. Township Fire paramedics arrived on scene and transported the patient to the hospital. Later the Fire Department's EMS coordinator advised that without Officers Brown's and Pernie's actions this patient may very well have passed away.

LIFE SAVING



Dispatcher James Crowe

On August 13, 2014 Dispatcher Crowe observed a male prisoner rubbing his left arm and leg. Prior to starting his shift, Disp. Crowe was advised the prisoner had an extensive medical history. Recognizing these actions as signs of a stroke or heart attack, Dispatcher Crowe immediately contacted a supervisor, who then called for paramedics. The prisoner was thought to be having a stroke and was transported to a hospital for treatment. If not for Dispatcher Crowe's keen observations and attention to duty this prisoner may have not survived the night.



MERITORIOUS SERVICE



Officer Edward Ryan, Officer Tim Newsome, Officer Elliot Wilson

On September 29, 2014 officers, was dispatched to a B&E alarm at Motor City Power Sports. While in route, Officers were given a description of the suspect and advised that a window to the business had been broken. When officers arrived at the scene of the burglary, they began to search the area. Officer Ryan was able to review the security camera tape and convey a detailed description of the suspect, including a clothing description, to Officers Newsome and Wilson.

A short time later officers discovered a motorcycle discarded in the bushes near the business. Officers Newsome and Wilson located a subject walking in the area near the discarded motorcycle. While questioning the subject, officers located a backpack with the described suspect's clothing in it. They were able to determine that the subject was the person responsible for the burglary. Through communication and coordination, Officers Newsome and Wilson were able to develop probable cause to arrest the subject for Felony Breaking and Entering that later lead to the subject's prosecution.

MERITORIOUS SERVICE



Officer Anthony Woycehoski

On March 6, 2014 Officer Woycehoski began investigating several home invasions that occurred in Bloomfield Township that had ties to other Home Invasions in neighboring communities. In less than a week, at times working from home, Officer Woycehoski coordinated with area investigative units, collected and analyzed data to identify the responsible in these Home Invasions. Due to his dedication and perseverance Officer Woycehoski led a multijurisdictional team that led to the capture and arrest of a subject responsible for over 55 Home Invasions throughout Bloomfield Township, Farmington Hills and West Bloomfield Township.



HONORABLE MENTION

Officer James Shoemaker, Officer Bryan Pizzuti, Officer Ryan Smith, Detective Mindy Hess, Detective Todd Krumm, Deputy Damon Dorkins, Detective Shawn Wilson, Agent Matthew Wieas

On February 3, 2014 Officers responded to a report of a Home Invasion where one of the suspects was shot while fleeing the scene. Deputy Dorkins and Detective Wilson who were working in the area responded to offer assistance in locating the subject who fled the scene. Believing the suspect had fled the scene, they took it upon themselves to check area hospitals for patients being treated for gunshot wounds. Deputy Dorkins and Detective Wilson conducted surveillance on the ER at the hospital. They observed a subject with a gunshot wound being dropped off at the entrance to the ER. Believing the subject was involved in our crime; Detective Wilson detained the injured subject at the hospital. Deputy Dorkins followed the car, affected a traffic stop and detained the subjects. The information obtained through the traffic stop helped this department in its investigation at the beginning stages. Because of his quick thinking, patience and professionalism Deputy Dorkins was able to provide vital information in an investigation. Officer Smith was dispatched to the hospital in Pontiac to interview the subject that was brought into the E.R. with a gunshot wound. Officer Smith established a rapport with the subject and documented incriminating statements the subject made. Officer Smith advised the subject of his Miranda Rights and obtained a confession from the subject. The confession implicated two other subjects in the crime. Detectives were called in to investigate further and discovered the suspect had two other accomplices present during the crime. With the help of outside investigative units. Detectives Hess and Krumm were able to conduct numerous interviews with the original suspect and witnesses that eventually led to the identification of two more suspects. Because of their extensive knowledge of gang and drug activity in the area, Officers Pizzuti, Shoemaker and Agent Wieas were called in to assist in the location of the two other suspects who were alleged gang members and drug users living in the city of Pontiac. Officers were able to locate the two suspects and deliver them to investigators for further interviews. Because of their first-hand knowledge and diligence, the suspects confessed to investigators their involvement and all three suspects were charged with Home Invasion and Unarmed Robbery.



HONORABLE MENTION

Lieutenant Tim Abbo, Officer Jason Follman, Officer Edward Nolan, Officer Kelly McGraw, Officer Scott Schuknecht, Officer Tim Newsome, Dispatcher Kathleen Reynolds, Dispatcher James Crowe

On December 24, 2014 officers were dispatched to a report of a suicidal/homicidal subject who was making threats of killing any officers that responded to his home. Officers were advised the subject was an honorably discharged Marine suffering the effects of PTSD and armed with a pistol. As the incident unfolded Dispatchers Reynolds and Crowe worked diligently to coordinate law enforcement and EMS services for the Township by requesting neighboring jurisdictions handle calls for service. In addition to this, they worked together to gather information on the subject in the house enabling the officers to address tasks at hand unobstructed. The officers responded and formed a perimeter around the house. To avoid a prolonged standoff and exposing residents to possible gunfire, the officers quickly formed a plan to take the subject into custody. They waited until the subject came to his doorway unarmed then deployed a TASER to safely immobilize the subject. Through a well-coordinated effort the subject was able to be taken safely into custody and transported to the hospital for treatment and observation.

HONORABLE MENTION

Officer Aaron Sparks

On November 22, 2014, Officer Sparks was responding to the COSTCO to assist another officer with the a report of a Larceny from Auto. While in route, he was advised that the responsible vehicle had fled the scene; he obtained a description and direction of travel. Moments later, Officer Sparks spotted the vehicle and affected a traffic stop on it. Officer Sparks conducted a roadside investigation that led to the arrest of the suspect and the recovery of the items stolen from COSTCO parking lot and other locations. Officer Spark's diligence and perseverance led to the suspect being charged with numerous crimes.



HONORABLE MENTION

Officer Christopher Wegienka, Officer Joseph Borro

On May 26, 2014 Officers Wegienka and Borro were dispatched to the area of Orange Lake on the reports of people screaming for help. Officers were directed by residents to the center of Orange Lake where a male, female and their four year old son were neck deep in the cold water approximately 100 yards from shore unable to swim ashore. Immediately both officers worked to find a boat and oars to rescue the family. Officers Wegienka and Borro were able to locate a boat and row through the cold murky water to the stranded couple. Officer Wegienka retrieved the freezing four year old and provided care for the child as Officer Borro rowed to the safety of waiting paramedics. Officers then aided the Bloomfield Fire Department with the rescue of the parents.

DISTINGUISHED CITIZEN AWARD

ANDRIY HAVRLYSYSHYN

On November 22, 2014 Mr. Havrylysyshyn observed a subject pull on several car door handles in the parking lot of Costco. Mr. Havrylysyshyn observed the subject enter an unlocked vehicle and begin taking several items from the vehicle and started placing them into another vehicle. Mr. Havrylysyshyn exited his vehicle and began to take photos of the suspect, the suspect's vehicle and its license plate. Prior to the Officers arrival, Mr. Havrylysyshyn was able to provide dispatchers with a detailed description of the suspect and his vehicle which had fled the scene. It was Mr. Havrylysyshyn's extra ordinary actions, quick thinking and sense of duty that was instrumental in the apprehension of the suspect and the recovery of the stolen items.

DISTINGUISHED CITIZEN AWARD


CHRISTOPHER HOLLOWAY

On July 17, 2014 Mr. Holloway was entering the Lowes store when he heard an employee call to a subject that she needed to see his receipt for items he had in a shopping cart. Believing a theft was occurring, Mr. Holloway approached the subject and took control of the shopping cart. Mr. Holloway demanded the subject return to the store to show proof of purchase. The subject made an attempt to reclaim the cart but failed and chose to flee the scene. Mr. Holloway, thinking quickly, took photos of the suspect's vehicle and obtained its license plate. Mr. Holloway called 911 and relayed the information to dispatchers. Due to Mr. Holloway's quick and clear thinking along with his sense of duty, the suspect was located a short-time later and charged with Retail Fraud 2nd Degree.


The Bloomfield Township

located on southbound Telegraph
Road approximately one quarter
mile south of Long Lake Road. The
police department is located in the
lower level of Township Hall, directly below the Administrative Offices.
The Patrol Division, Investigations

Division, Records Section and Property Section are located in this area of the building. In addition to these sections, the dispatch center is located in a centralized portion of the building, along with the detention facilities, booking room and various interview rooms.

n June of 2005, a memorial to the service of Officer Gary Davis was constructed. It consists of a granite bench on the southwest corner of the police station. Officer Davis was killed after his patrol car was struck by another vehicle. The driver of that vehicle was subsequently arrested and convicted of driving while under the influence of



alcohol. It is a beautiful and fitting tribute to his life and service to the citizens of Bloomfield Township.

he police department operates a state-certified animal shelter. This state-of-the-art facility is staffed by two uniformed Animal Welfare Officers and one civilian employee. This building is capable of providing shelter for dogs, cats and a variety of other wildlife. The staff collects and provides temporary care for animals until the animal can be claimed or transported to a facility that can provide extended lodging.

nimal Welfare Officers answer questions from the public ranging from pet care to animal adoptions. They assist the police department in the collection and disposal of deceased wildlife, and are occasionally called upon to enforce State and Township laws and ordinances regarding pets. These knowledgeable officers also assist citizens with the trapping and prevention of nuisance animals.






Patrol Division

Patrol Division

loomfield Township Police Department Patrol Division consists of 46 sworn uniformed officers. The Police Department maintains a minimum staffing level at all times. The officers' work days are divided into two 12-hour shifts. At any given time, there is a minimum of 5 officers on patrol, not including command officers and specialty divisions such as K-9 and Traffic Investigations.



The Patrol division is staffed 24 hours a day, 7 days a week, 365 days a year. Bloomfield Township is divided into three "districts" or patrol areas. These districts are staffed every shift to provide the quickest response times. These districts are also complimented by additional staffing from specialty units that are not assigned to districts, and focus on selective enforcement areas (i.e. speeding, break-ins, etc.).



Traffic Investigations Unit

loomfield Township Police Department demonstrates their excellence in service to the community by being one of the cofounders of S.O.C.C.I.T. (Southeastern Oakland County Crash Investigation Team).



his mulit-jurisdictional team combines the expertise and knowledge of multiple Traffic Crash Reconstruction Investigators, while keeping expenses at a minimum to Bloomfield Township. This team consists of experts in areas of: Traffic Crash Reconstruction, Drug Recognition and Advanced Roadside Impaired Driver Experts(A.R.I.D.E.), Child Safety Seats, Motor Carrier Enforcement as well as Motorcycle and Pedestrian Crash Investigations. In the event of a serious injury or fatal traffic crash, team members from each agency will arrive on scene to assist with the investigation. This mutual aid agreement between agencies aids in the investigations process as well as relieves the "host" agency from shouldering the burden of a costly and resource draining investigation. S.O.C.C.I.T. has been recognized internationally as a model for multi-jurisdictional teams. This team has also received state recognition and an award for the efforts of its members.

Public Safety Dispatch Center

he nerve center of any public safety department is the Dispatch center, also known as the P.S.A.P. (Public Safety Answering Point). The Dispatch center receives all telephone calls for both the Police Department



and the Fire Department. The 13 Dispatchers answer both nonemergency and 911 calls. They enter calls into the C.A.D. (Computer Aided Dispatching) system and dispatch both police and fire personnel as required. All 13 of Bloomfield Township's dispatchers are specially trained to handle telephone calls that can range from a hysterical caller that can not communicate vital information to a cat stuck in a tree.

loomfield Township Dispatchers are tasked with monitoring multiple live-feed security cameras throughout the Bloomfield Township campus. They also monitor the behavior and well being of any arrestee held in the police departments detention facility.

The Court Officer

he Bloomfield Township Police Department files all criminal cases through the 48th District Court as well as the Oakland County Circuit Court. The Police Department's Court Officer position is re-



sponsible for these cases. This assignment consists of being the liaison between the courts, the prosecutors (Township and State), and the Police Department. This officer maintains all prisoner property during their cases with Bloomfield Township. The court officer conducts prisoner transports to and from court appearances, provides transportation to area detention facilities, conducts video arraignments, completes paperwork and submits warrant requests to the Oakland County Prosecutor's Office.

Training Division



raining is vital in Law Enforcement. The Bloomfield Township Police Department remains an elite agency due to the dedication and fortitude of the training staff. The training staff consists of both Patrol Officers and Command Staff that are specially trained in specific areas of law enforcement.

The goal of the training division is to provide the best possible training for officers and staff within the department.

These dedicated professionals work regular duty shifts and take on the additional responsibility of becoming a trainer in a specific discipline of law enforcement. Areas of expertise include defensive tactics, firearms, motorcycle handling, traffic crash investigations, medical first response, OWI investigations, and Field Training. Training Officers attend classes and become highly educated in their area of expertise, then return to instruct classes for department personnel.

The unique residential community of Bloomfield Village is a part of Bloomfield Township where the residents have chosen to fund one additional property tax mill to support the cost of additional law enforcement presence. Through this arrangement, the Patrol Division of the Bloomfield Township Police Department and the Bloomfield Village Police Department share law enforcement patrol responsibilities in Bloomfield Village. Criminal matters requiring extensive follow up investigations remain under the jurisdiction of Bloomfield Township. The Bloomfield Village Police Department consists of four full-time patrol officers under the field supervision of one patrol sergeant and operates out of its own police and fire facility at 3595 Bradway Boulevard.

he Investigations Division is led by a Lieutenant and Detective Sergeant. This division is staffed by five full time Detectives, two school liaison officers and one school security officer. The primary job of these individuals is to investigate criminal complaints. The complaints range from serious felonies such as homicide to misdemeanors like underage drinking violations. Detectives are police officers that are promoted; they receive additional training in interview and interrogation techniques, crime scene investigation, search and seizure law, preservation and collection of evidence.

his division also oversees the Bloom-field Township officers assigned to specialty units such as the Narcotics Enforcement Team (NET), Special Investigations Unit (SIU) and the F.B.I.'s Violent Crimes Task Force (VCTF). The Investigations Division interacts with many outside law enforcement agencies including the FBI, Secret Service, ATF, DEA and Customs. Members of the Investigations Division participate regularly with the Major Case Assistance Team (MCAT).

School Liaison Officer Activity

he Bloomfield Township Police has two officers assigned to the Bloomfield Hills School District. The School Liaison Officers estab-

lish a familiarity between the community's youth and police officers with the officer being the link between law enforcement and the school district. The duties of the School Liaison Officer is to handle any complaints or incidents as they relate to students of the Bloomfield Hills School District. These officers work with school staff, administrators, parents as well as other law enforcement agencies as a resource to better direct the youth of the school district.

These officers also get assigned criminal cases, similar to a detective and investigate them to completion.


Property Section

nce an alarm has been installed you will be required to register your system with the Township. This takes just a few minutes to do. For more information about registering your alarm system call 248-433-7776.





always be prepared to act responsibly and in accordance with the laws. One of the most common misconceptions is reporting traffic crashes.

Traffic crashes typically fall into one of two categories, public roadway or private property. Each requires different responses from both the driver as well as the police.

If you are involved in a traffic crash on private property you are obligated to contact the driver (or owner, if unattended) of the struck vehicle. If you can not locate the driver (owner) you are obligated to contact the police immediately.

If you are involved in a traffic crash on a public roadway, no matter the amount of damage to the vehicles, you are obligated to contact the police.

raffic enforcement is a significant portion of Law Enforcement. This task is accomplished through the education or issuance of a citation to a violating driver. Most traffic violations do not require an intent to break the vehicle laws. The primary reason for traffic tickets is the education of a driver.

The Bloomfield Township Police Department holds traffic safety of the utmost importance. There are three Officers and one Sergeant assigned to the Traffic Investigations Unit. This unit's sole responsibility is the promotion



of traffic safety through the assistance, training, education and enforcement of the Michigan Motor Vehicle Code. These officers' skill sets range from child safety seat laws and installation to advanced physics for the reconstruction of traffic crashes.

Animal Welfare

Bloomfield Township is served by two uniformed Animal Welfare Officers and one civilian employee.



These dedicated officers operate out of the statecertified animal shelter, conduct routine patrols and respond to animal calls both wild and domestic. They also complete reports, maintain and care for sheltered animals.




The officers commonly are called to pick up and dispose of deceased wildlife both on and off the roadway. Bloomfield Township has a contract with Oakland County to dispose of larger deceased animals. Smaller animals are taken to Gasow Veterinary Clinic for treatment or disposal. While the operating cost of the animal shelter are covered by Bloomfield Township, other expenses are offset by public donations (i.e. food, blankets and animal toys).
