#### During the year, 10 meetings were held.

The following Ordinances amending Zoning Ordinance No. 265 were studied and sent to the Township Board for ratification since January 1, 2002.

## **Text Changes**

- Ord. No. 530 Approved to amend the Township's Zoning Ordinance No. 265, to create a new B-4 classification, to be known as the "Planned Business District".
- Ord. No. 531 Approved to amend the Township Zoning Ordinance No. 265, to add definitions and provisions for regulated uses.
- Ord. No. 533 Approved to amend the Township Zoning Ordinance No. 265, to provide the option for developers to develop certain residential property with 50% of Open Space.
- Ord. No. 534 Approved to amend the Township Zoning Ordinance No. 265, to establish the membership of the Board of Zoning appeals. The number comprising the Board to be changed from "five" as written to "seven" and thus "the remaining three" changed to read "the remaining five".

- 4. Discussion of the adoption of by-laws to handle procedural issues of the Township Planning Commission.
