#### **ORDINANCE NO. 666**

AN ORDINANCE TO AMEND SECTION 42-3.2 ZONING MAP, CHAPTER 42, ZONING, OF THE CODE OF ORDINANCES OF THE CHARTER TOWNSHIP OF BLOOMFIELD.

#### THE CHARTER TOWNSHIP OF BLOOMFIELD ORDAINS:

#### Section 1.

Article 3, Zoning Districts, Section 42-3.2 Zoning Map, is hereby amended by changing the zoning classification on the following described parcel located at the east side of Telegraph Road and north of Crestview Avenue from ML-1 Light Manufacturing to B-3 General Business, based on the submitted site plan:

#### Section 2. Repealer.

All ordinances or parts of ordinances in conflict with this ordinance are repealed only to the extent necessary to give this ordinance full force and effect.

#### Section 3. Severability.

If any section, clause or provision of this Ordinance shall be declared to be unconstitutional, void, illegal or ineffective by any Court of competent jurisdiction, such section, clause or provision declared to be unconstitutional, void or illegal shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force and effect.

#### Section 4. Savings.

All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law when they were commenced.

#### Section 5. Effective Date.

The provisions of this Ordinance are hereby ordered to take effect immediately upon publication.

#### Section 6. Adoption.

This Ordinance is hereby declared to have been adopted by the Township Board of the Charter Township of Bloomfield at a meeting thereof duly called and held on the 24<sup>th</sup> day of February 2020, and ordered to be given publication in the manner prescribed by the Charter Township of Bloomfield.
