This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. However, it does not include every incident reported to the Police Department. It is possible for publicity to hinder some criminal investigations. In these situations, we do not release information unless it is in the community's best interest or we are certain it will not compromise an investigation.

Summary:

During the timeframe of July 21, 2025, through July 27, 2025, Bloomfield Township Officers handled 567 calls for service, 202 of which were traffic stops.

Traffic Crashes:

Officers investigated 39 total traffic crashes during this timeframe: 23 Property Damage Crashes, 7 Personal Injury Crashes, 3 Hit and Run Crashes, 1 Private Property Crash, 5 Car vs. Deer Crashes, and 0 Non-UD-10 Crashes.

2105 S. Telegraph Road (Dick's Sporting Goods)

On July 26, 2025, at approximately 5:25 p.m., the Bloomfield Township Police Department was dispatched to 2105 S. Telegraph Road, Dick's Sporting Goods, for a retail fraud in progress. Employees reported five juvenile boys stealing items and exiting the store. Officers arrived on scene and located two of the boys and recovered \$323.20 worth of merchandise. Items stolen included four pairs of boxer briefs, a mouth guard, and a beanie hat. The boys were transported to the Bloomfield Township Police Department where they were turned over to their guardians.

25-15294 Retail Fraud

2105 S. Telegraph Road (Dick's Sporting Goods)

On July 26, 2025, at approximately 3:10 p.m., the Bloomfield Township Police Department was dispatched to 2105 S. Telegraph Road, Dick's Sporting Goods, for a retail fraud that just occurred. The suspect left the store in a Crown Victoria. Officers obtained a license plate for the vehicle and sent a be on the lookout to area departments. Taylor Police Department was able to locate the vehicle with the suspect still inside. Recovered from the vehicle was a stolen "Bogg" bag and fourteen (14) varying Yeti cups totaling just under \$600.00 in value. Taylor Police Department arrested the suspect, and Bloomfield Township Officers met Taylor Police Department to take the suspect in custody. The suspect, a 56-year-old male from Taylor, was interviewed and fingerprinted at the Bloomfield Township Police Department. He released pending the authorization of charges from the Oakland County Prosecutor's Office.

25-15124 B&E Forced Entry

43034 Woodward Avenue (The Moose Preserve)

On July 24, 2025, at approximately 8:00 a.m., the Bloomfield Township Police Department was dispatched to 43034 Woodward Avenue, the Moose Preserve restaurant, for a burglary that occurred sometime overnight. Workers arrived at the restaurant and found one of the rear patio doors broken and multiple items taken from the restaurant. Stolen from the restaurant was an iPad, a bottle of tequila, and multiple cash drawers. Officers were able to locate the iPad not far from the restaurant and an empty cash drawer in a nearby dumpster. It is unknown at this time how much cash was in each of the drawers. This case was turned over to the Bloomfield Township Police Investigations Unit and is currently under investigation.
