*This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. ### **Summary:**

During the timeframe of June 15, 2026, through June 21, 2026, Bloomfield Township Officers handled 602 calls for service, 209 of which were traffic stops.

### **Traffic Crashes:**

Officers investigated 47 total traffic crashes during this timeframe: 23 Property Damage Crashes, 8 Personal Injury Crashes, 5 Hit and Run Crashes, 6 Private Property Crashes, 2 Car vs. Deer Crashes, and 3 Non-UD-10 Crashes.

**Retail Fraud 3<sup>rd</sup> Degree**  
**4099 Telegraph Road (Kroger)**

**Arrest Made**

On June 20, 2026, at approximately 5:30 p.m., the Bloomfield Township Police Department was dispatched to Kroger, located at 4099 Telegraph Road for a Retail Fraud. Officers were advised that an ex-employee was inside the store trying to steal a bottle of wine after entering the store through an employee only door. The suspect was stopped near the front of the store and detained. Officers determined he also stole a bottle of chili sauce and a bar of chocolate. The total value of the merchandise stolen was \$23.55. The suspect, a 41-year-old white male from Bloomfield Hills, was subsequently arrested for Retail Fraud 3<sup>rd</sup> Degree. He was issued a citation and released from the scene pending a court date.

**Retail Fraud 2<sup>nd</sup> Degree**  
**4099 Telegraph Road (Kroger)**

On June 19, 2026, at approximately 8:30 p.m., the Bloomfield Township Police Department was dispatched to Kroger, located at 4099 Telegraph Road for a Retail Fraud that had just occurred. Officers were advised that the suspect had just fled northbound Telegraph in a red Hyundai. Officers located the vehicle on Franklin near Square Lake Road and attempted to stop it. The Hyundai fled from officers and crashed on Luther Avenue. The driver of the vehicle fled on foot and the three remaining female occupants were questioned about the Retail Fraud. Officers recovered the stolen merchandise, which consisted of 11 bottles of shampoo/conditioner, 6 packages of meat, 2 packages of shrimp, and 12

packages of chicken wings. The total value of the recovered merchandise was \$305.66. This case was turned over to the Bloomfield Township Investigations Unit and is currently under investigation. Anyone with information is urged to call Bloomfield Township at 248-433-7755.
