#### **Summary:**

During the timeframe of May 5, 2025, through May 11, 2025, Bloomfield Township Officers handled 506 calls for service, 134 of which were traffic stops.

### 25-7560 Retail Fraud 2nd Degree 2185 S. Telegraph Rd.

On May 7, 2025, the Bloomfield Township Police Department took a report for Retail Fraud 2nd Degree from 2185 S. Telegraph Rd., Home Goods. It was reported that two males came into Home Goods and stole four comforter sets and one toaster oven totaling \$599.95. Both suspects were described as 30-40-year-old black males, this case was turned over to the Bloomfield Township Investigations unit and is currently under investigation. ### 25-8526 Unlawful Driving Away of Automobile 1501 S. Opdyke Road

**Arrest Made** 

On May 5, 2025, the Bloomfield Township Police Department took a report for Unlawful Driving Away of Automobile from 1501 S. Opdyke Road, Mobil Gas Station. The victim stated they parked their black 2015 Buick Verano unlocked and running, near the main entrance of the gas station, while they went inside. While the victim was inside he saw his vehicle drive off. The suspect was described as a white male wearing a red Adidas zip up hoodie and faded blue jeans. The vehicle was recovered a few hours later by another jurisdiction on a traffic stop. The suspect/driver was identified as Christopher Henthron, 38 years old from Gibraltar. Henthron was arrested and the Oakland County Prosecutor's Officer issued UDAA charges against him.

On May 9, 2025, Henthron was arraigned by Magistrate Nelson-Klein of the 48<sup>th</sup> District Court who set a bond of \$20,000.
