This report provides a summary of many arrests, incidents, events and other items of significance occurring in Bloomfield Township. However, it does not include every incident reported to the Police Department. It is possible for publicity to hinder some criminal investigations. In these situations, we do not release information unless it is in the community's best interest or we are certain it will not compromise an investigation.

Summary:

During the timeframe of November 17, 2025, through November 23, 2025, Bloomfield Township Officers handled 589 calls for service, 203 of which were traffic stops.

Traffic Crashes:

Officers investigated 48 total traffic crashes during this timeframe: 23 Property Damage Crashes, 5 Personal Injury Crashes, 5 Hit and Run Crashes, 8 Private Property Crashes, 6 Car vs. Deer Crashes, and 1 Non-UD-10 Crash.

25-24126 Retail Fraud

2400 S. Telegraph Road (Target)

On November 22, 2025, the Bloomfield Township Police Department was dispatched to a Retail Fraud at Target, 2400 S. Telegraph Road. Loss Prevention staff had a white female suspect in their office they caught on stealing on video surveillance. The suspect entered the store at approximately 4:30 p.m., and took a shopping cart down multiple aisles selecting merchandise. The suspect was seen removing price tags from low priced items and affixing them to higher priced items in her cart. At 4:54 p.m., the suspect went through the self-checkout and scanned some, but not all, of her items selected and used the discount price tags for other items. The female attempted to steal \$243.90 worth of hangers, Christmas decorations, storage bins, and a steam iron. Officers took the female in custody. This case is currently pending charges.

25-23914 Larceny from Automobile 2600 of Douglas Road

On November 20, 2025, Bloomfield Township Officers took a report in the lobby for a larceny of registration tabs. The victim had her 2026 Michigan Registration Tab stolen off her Ford between November 11, 2025 and November 16, 2025. The larceny was documented for the victim to receive a replacement from the Secretary of State.

25-23873 Larceny from Automobile

5400 block of Wing Lake Road

On November 20, 2025, the Bloomfield Township Police Department responded to a report of a Larceny from Automobile that occurred at 6:20 a.m. The victims observed on their home surveillance camera four unknown suspects entering two vehicles in their driveway, a Range Rover and a Land Rover. Both vehicles were left unlocked in the driveway. It's believed that five packages of Christmas lights were stolen from the vehicle. Video surveillance showed four unknown subjects in dark coats, hoodies, and ski masks approaching and entering both vehicles. This case was turned over to the Bloomfield Township Police Investigations Unit and is currently under review. 25-23684 Retail Fraud

2400 S. Telegraph Road (Target)

On November 17, 2025, the Bloomfield Township Police Department was dispatched to a Retail Fraud in progress at Target, 2400 S. Telegraph Road. At approximately 10:45 a.m. two black male suspects were seen in the electronics section removing security devices and concealing two PS5 controllers in their pants. Officers arrived on scene and located the suspects. Two 18-year-old males from Pontiac, MI, were taken into custody. A pair of scissors and two PS5 controllers were recovered from their persons. During the investigation, Officers learned that the two suspects were also involved in similar thefts on November 10, 2025 and November 11, 2025 at the same Target Store. In those incidents the suspects stole multiple PS5 controllers.

This case was presented to the Oakland County Prosecutor's Office who issued charges on Delorian Devon Anderson and Zion Vanshon Hill. Anderson was charged with two counts of Retail Fraud 2nd Degree, one count Retail Fraud 3rd Degree, and three counts of Theft Detection Device Removal. Hill was charged for one count of Retail Fraud 2nd Degree and one count of Retail Fraud 3rd Degree. Anderson and Hill were both arraigned at the 48th District Court. Anderson received a \$7,500/10% cash bond and Hill received a \$5,000/personal bond.
