NOTICE OF HEARING OF ASSESSMENT ON SPECIAL ASSESSMENT IMPROVEMENTS

SANITARY SEWER EXTENSION BLOOMFIELD ADAMS MANOR SUBDIVISION, SECTION 24 SPECIAL ASSESSMENT DISTRICT NO. 410

TO THE OWNERS OF THE FOLLOWING DESCRIBED PROPERTIES:

T2N, R10E, Section 24, Bloomfield Adams Manor Subdivision, Lot 6 and Lot 7.

All in Bloomfield Township, Oakland County, Michigan.

PLEASE TAKE NOTICE THAT the Township Board of the Charter Township of Bloomfield has declared its intention to make the following improvements:

Construction of sanitary sewer extension and appurtenances as follows:

Beginning at the existing sanitary sewer located at Kensington Road and Big Beaver Road, extend a 10 inch diameter sanitary sewer northerly approximately 350 feet along Kensington Road to Ivy Lane, thence 170 feet along Ivy Lane to a terminus manhole.

In addition, the Township Board has designated the special assessment district against which the cost of said improvements is to be assessed as consisting of all lots and parcels of land as set forth above. The tentative special assessment roll can be found on the Township website, http://www.bloomfieldtwp.org/Government/LegalNotices.asp, and/or at the Township Clerk's office for inspection during regular business hours, Monday through Thursday, 7:00 a.m. – 5:30 p.m.

TAKE FURTHER NOTICE that the Township Board will meet on <u>MONDAY, MARCH 23, 2015</u>, at 7:00 p.m. in the BLOOMFIELD TOWNSHIP HALL, 4200 Telegraph Road for the purpose of hearing any objections to the improvements and to confirm the special assessment roll.


