- Friday, October 25, 2024, from 12:00 p.m. to 5:00 p.m.
- Friday, November 1, 2024, from 12:00 p.m. to 5:00 p.m.
- Saturday, November 2, 2024, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 5, 2024, from 7:00 a.m. to 8:00 p.m.
