**NOTICE OF REGISTRATION**  
**FOR THE GENERAL ELECTION TO BE HELD ON**  
**TUESDAY, NOVEMBER 5, 2024**

To the qualified electors of the CHARTER TOWNSHIP OF BLOOMFIELD, County of Oakland:

Any qualified elector of Bloomfield Township who is not already registered may register to vote at the Bloomfield Township Clerk's Office, the office of the County Clerk, a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at <https://mVIC.sos.state.mi.us/> and mailed to the Township Clerk. Voters who are already registered may also update their registration.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 21, 2024**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Bloomfield Township Clerk's Office, located at 4200 Telegraph, Bloomfield Hills, MI, 48302 at the following times:

- Regular business hours: Monday – Thursday from 7:00 a.m. to 5:30 p.m.
- Sunday, October 13, 2024, from 11:00 a.m. to 3:00 p.m.
- Friday, October 25, 2024, from 12:00 p.m. to 5:00 p.m.
- Friday, November 1, 2024, from 12:00 p.m. to 5:00 p.m.
- Saturday, November 2, 2024, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 5, 2024, from 7:00 a.m. to 8:00 p.m.

The election will be conducted in all voting precincts of the Charter Township of Bloomfield for the purpose of electing candidates for the following offices:
