PLEASE TAKE NOTICE that the Charter Township of Bloomfield will vote on the following millage proposal: Oakland Community College Operating Millage Renewal Proposal

This proposal authorizes Oakland Community College to continue to levy 0.7545 mills for operating purposes for 10 years as a renewal of millage previously approved by the electors in 2010, which expires with the 2021 tax levy.

Voters in the Birmingham Public School District will also vote on the following millage proposal: Birmingham Public Schools Replacement Operating Millage Proposal

This proposal would restore, replace and extend the authority of the Birmingham Public Schools to levy up to 18.00 mills for general school district operating purposes on taxable property in the School District to the extent that such property is not exempt from such levy and would restrict the levy on principal residences (owner occupied homes) to no more than 14.24 mills.
