The proposed special assessment roll reflects an increase with riparian parcels assessed \$1,179. 28 per year and lake access parcels assessed \$747.44 per year. - To appeal: you must file a written appeal of the special assessment with the Michigan Tax Tribunal within 30 days after the Notice of Confirmation of the Special Assessment Roll has been published in the Oakland Press newspaper.
