SUMMARY OF INTRODUCTION OF PROPOSED ORDINANCE NO. 693

Amendments to the Zoning Ordinance for Multiple Family Residential Accessory Uses in the B-2 Community Business District

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF BLOOMFIELD TOWNSHIP, CHAPTER 42, ZONING, TO AMEND THE PROVISIONS TO ALLOW ACCESSORY USES AND STRUCTURES IDENTIFIED IN THE RM DISTRICT FOR MULTIPLE FAMILY DEVELOPMENT AS PERMITTED USES IN THE B-2 COMMUNITY BUSINESS DISTRICT.

The purpose of Proposed Ordinance 693 is to allow accessory uses and structures customarily incidental to multiple family residential development on abutting property zoned B-2 Community Business for the convenience of the development's residents.

At a PUBLIC HEARING on Monday, April 14, 2025, 7:00 p.m., the Bloomfield Township Board of Trustees will consider adoption of Proposed Ordinance 693. ORDINANCE NO. 693

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF BLOOMFIELD TOWNSHIP, CHAPTER 42, ZONING, TO AMEND THE PROVISIONS TO ALLOW ACCESSORY USES AND STRUCTURES IDENTIFIED IN THE RM DISTRICT FOR MULTIPLE FAMILY DEVELOPMENT AS PERMITTED USES IN THE B-2 COMMUNITY BUSINESS DISTRICT.

THE CHARTER TOWNSHIP OF BLOOMFIELD ORDAINS:

Section 1.

Article 3.0, Zoning Districts, Section 42-3.1.6.B B-2 Community Business Principal Permitted Uses is hereby amended to add:

Sec. 42-3.1.6.B. Principal Permitted Uses

[i through viii to remain]

ix. Accessory uses and accessory structures permitted in RM districts when such uses are for the convenience of the multiple family residents in the abutting RM district, subject to the applicable standards of the RM district.

Section 2. Repealer.

All ordinances or parts of ordinances in conflict with this ordinance are repealed only to the extent necessary to give this ordinance full force and effect.

Section 3. Severability.

If any section, clause or provision of this Ordinance shall be declared to be unconstitutional, void, illegal or ineffective by any Court of competent jurisdiction, such section, clause or provision declared to be unconstitutional, void or illegal shall thereby cease to be a part of this Ordinance, but the remainder of this Ordinance shall stand and be in full force and effect.

Section 4. Savings.

All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law when they were commenced.

Section 5. Effective Date.

The provisions of this Ordinance are hereby ordered to take effect seven days after publication.

Section 6. Adoption.

This Ordinance is hereby declared to have been adopted by the Township Board of the Charter Township of Bloomfield at a meeting thereof duly called and held on the _____day of ______, 2025, and ordered to be given publication in the manner prescribed by the Charter Township of Bloomfield.
