## NOTICE OF VIRTUAL PUBLIC HEARING REZONING REQUEST IN CONJUNCTION WITH SITE PLAN AND SPECIAL LAND USE PROPOSAL

PLEASE TAKE NOTICE THAT the Board of Trustees of the Charter Township of Bloomfield, Oakland County, Michigan will hold a Virtual Public Hearing (via Zoom) on **Monday, May 10, 2021 at 7:00 p.m.** in the Bloomfield Township Hall Auditorium, 4200 Telegraph Road, Bloomfield Hills, MI 48302.

At the Public Hearing, the Board will hear comments regarding a rezoning request conditioned upon development according to a submitted site plan. The proposal pertains to vacant property located on the east side of Telegraph Road and north of Square Lake Road. The owner is seeking approval to rezone a 0.56 acre parcel from B-2 Community Business to B-3 General Business as part of a site plan and special land use proposal to construct a new Valvoline Oil Change.


