PLEASE TAKE NOTICE THAT the Township Board of the Charter Township of Bloomfield has tentatively declared its intention to make the following improvements:

The paving (and associated construction items) of the roads within the Concord Green Subdivision including, but not limited to, Lamplighter Lane, Lamppost Lane, Lampwick Court, and Candlestick Court.

The project consists of reconstructing the existing roads with placing a bituminous (asphalt) pavement four (4) inches thick at full width on the conditioned roadbed. A limited amount of drainage improvements will be made to reasonably assure drainage of the pavement. All shoulders and disturbed areas will be covered with topsoil and sod. A maximum five (5) foot approach will be constructed to existing driveways to provide a smooth transition from the newly paved roadway.


