After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Bloomfield Township Clerk's Office, located at 4200 Telegraph, Bloomfield Hills, MI, 48302 at the following times:

- Regular business hours: Monday Thursday from 7:00 a.m. to 5:30 p.m.
- Friday, July 24, 2020, from 10:00 a.m. to 4:00 p.m.
- Friday, July 31, 2020, from 10:00 a.m. to 5:00 p.m.
- Saturday, August 1, 2020, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, August 4, 2020, from 7:00 a.m. to 8:00 p.m.
