## NOTICE OF REGISTRATION FOR THE STATE PRIMARY ELECTION TO BE HELD ON TUESDAY, AUGUST 2, 2022

To the qualified electors of the CHARTER TOWNSHIP OF BLOOMFIELD, County of Oakland:

**PLEASE TAKE NOTICE** that any qualified elector of Bloomfield Township who is not already registered may register to vote at the Bloomfield Township Clerk's Office, the office of the County Clerk, a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at <a href="https://www.mi.gov/vote">www.mi.gov/vote</a> and mailed to the Township Clerk. Voters who are already registered may update their registration at <a href="https://www.expressSOS.com">www.expressSOS.com</a>.

The last day to register in any manner other than in-person with the local clerk is **Monday, July 18, 2022.** After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Bloomfield Township Clerk's Office, located at 4200 Telegraph Road, Bloomfield Hills, MI, 48302 at the following times:

- Regular business hours: Monday Thursday from 7:00 a.m. to 5:30 p.m.
- Friday, July 22, 2022, from 10:00 a.m. to 3:00 p.m.
- Saturday, July 23, 2022, from 10:00 a.m. to 3:00 p.m.
- Friday, July 29, 2022, from 10:00 a.m. to 3:00 p.m.
- Saturday, July 30, 2022, from 10:00 a.m. to 3:00 p.m.
- Sunday, July 31, 2022, from 1:00 p.m. to 4:00 p.m.
- Election Day, Tuesday, August 2, 2022, from 7:00 a.m. to 8:00 p.m.

The election will be conducted in all voting precincts of the Charter Township of Bloomfield for the purpose of *nominating* candidates for the following offices:

**STATE** Governor

**CONGRESSIONAL** Representative in Congress

**LEGISLATIVE** State Senator, Representative in State Legislature

**COUNTY** County Commissioner

And for the purpose of electing:

Precinct Delegates to the County Convention of the Republican and Democratic parties

And to vote on the following ballot proposals:

- TOWNSHIP: Public Safety Millage Replacement
- VOTERS IN THE BLOOMFIELD HILLS SCHOOL DISTRICT: Operating Millage Restoration Proposal
- VOTERS IN THE SCHOOL DISTRICT OF THE CITY OF PONTIAC: Operating Millage Restoration Proposal
