Public Comments regarding this proposal may be made in one of the two following ways for no more than three minutes for each person.

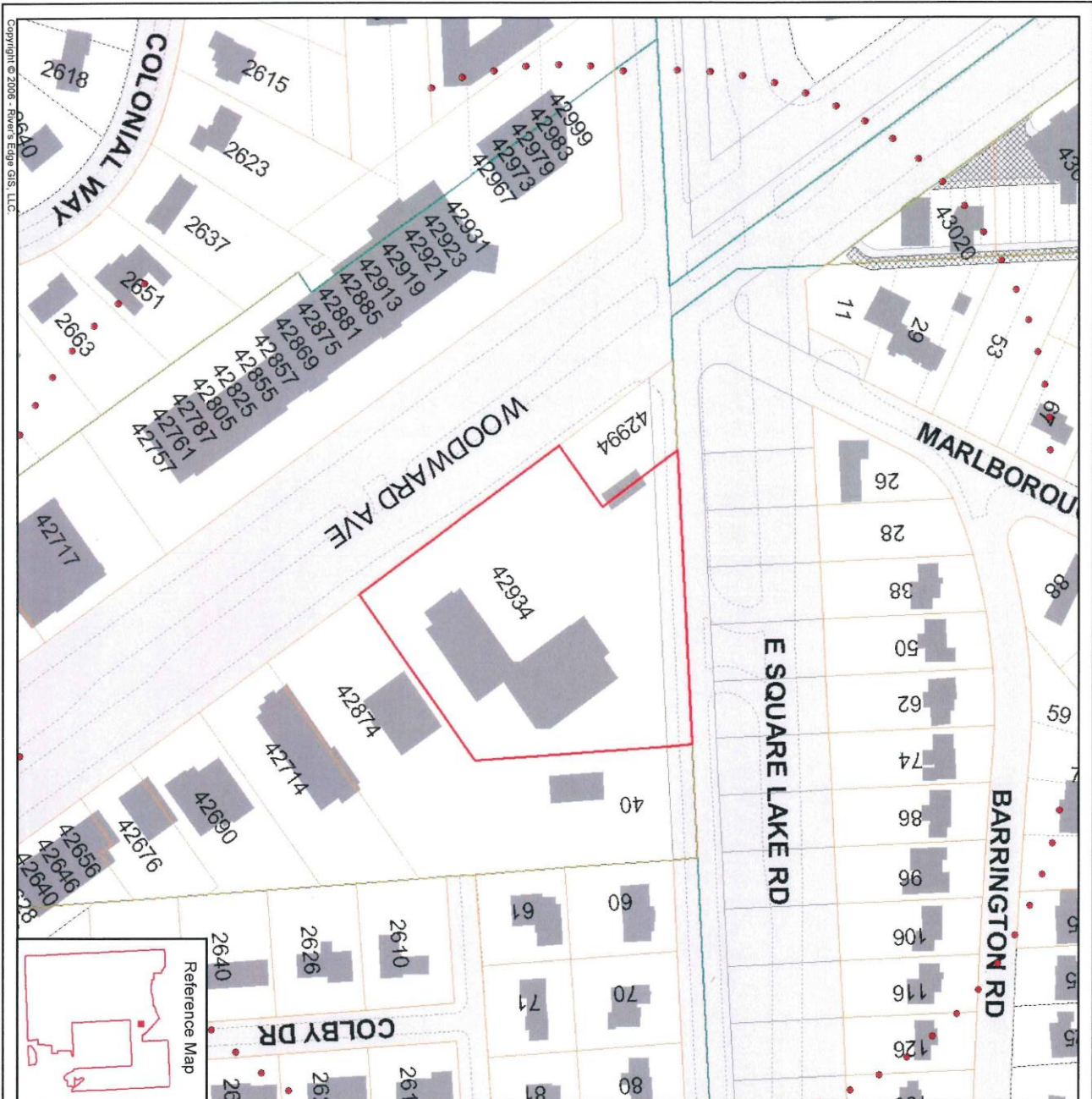

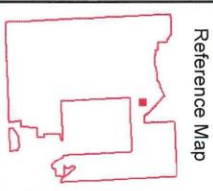
