PLEASE TAKE NOTICE that the Township Board of the Charter Township of Bloomfield has declared its intention to make the following improvements:

The paving (and associated construction items) of the roads within the Sandalwood Condominium including, but not limited to, N. Adams Way, Justin Ct., and S. Adams Way, as well as the driveways for each unit from the back of curb to the garage door, which roads have a total frontage of 4,049 feet.

A bituminous (asphalt) pavement four (4) inches thick will be placed atop the existing aggregate base course or conditioned subbase in disturbed areas. All concrete curb and gutter will be removed and replaced and subgrade edge drain will be installed under the proposed curb along both sides of the road. All driveways will be replaced with four (4) inches of asphalt over the existing base course. The driveway replacement will extend from the back of the curb to the garage door. Improvements to the storm sewer system will be made including the replacement of 283 feet of twelve (12) inch and fifteen (15) inch storm sewer, approximately 30 feet of eighteen (18) inch culvert, and rebuilding approximately 12 drainage structures. All shoulders and disturbed areas will be covered with topsoil and sod.

In addition, the Township Board has designated the special assessment district against which the cost of said improvements is to be assessed as consisting of all lots and parcels of land as set forth above. The to-date plans and estimates for the special assessment district are on file in the Bloomfield Township Clerk's Office, 4200 Telegraph Road, Bloomfield Hills, MI 48302.

TAKE FURTHER NOTICE that the Township Board will meet on <u>Monday, August 10, 2020 at 7:00 p.m.</u> in the Bloomfield Township Hall, 4200 Telegraph Road, Bloomfield Hills, MI 48302 for the purpose of hearing any objections to the special assessment roll or the special assessment district itself.

In order to appeal the amount of the special assessment to the state tax tribunal, your appearance and protest are required at the Hearing of Special Assessment. Appearance and protest may be made by a property owner or party in interest, or his or her agent, in person, or such protest is permitted by letter, without the necessity of a personal appearance.
